Kurdistan Regional Government Delegation Visits Washington

WASHINGTON, D.C. - A high-level official delegation from the Kurdistan Regional Government (KRG) recently visited Washington, D.C. from April 8-12.

Dr. Fuad Hussein, Chief of Staff to President Barzani, lead the delegation that met with the Obama Administration, including National Security Council Staff, Deputy Secretary of Energy Daniel Poneman, Assistant U.S. Trade Representative Michael Delaney, and Assistant Secretary of State Beth Jones, among others.

The delegation spent a day meeting with key Members of Congress and staff, including the Kurdish American Congressional Caucus (KACC) led by Co-Chair Jared Polis (D-CO), Senators John McCain (R-AZ), Roger Wicker (R-MS), Representatives Mike Rogers (R-MI), Ed Royce (R-CA), Chris Van Hollen (D-MD), and House Majority Leader Eric Cantor (R-VA).

In these meetings the delegation provided their insight into the ongoing conflict in neighboring Syria, as well as continued dialogues with U.S. leaders on political and economic developments in the Kurdistan Region and Greater Iraq.

Halabja Survivors on Capitol Hill


This year marks the 25th Anniversary of the attack on Halabja, and members of the organization, Survivors of Halabja, were in Washington, D.C. to meet with Members of Congress, the State Department, NGOs, and Administration staff.

The town of Halabja is located approximately 150 miles northeast of Baghdad. In March of 1988, Saddam Hussein's military used chemical weapons in a horrific attack on this town. At least 5,000 people were killed and an estimated 7,000 more were injured in the attack.

The survivors met with the offices of Congressmen Chris Smith (R-NJ), Frank Wolf (R-VA), Chris Van Hollen (D-MD), Congresswoman Frederica Wilson (D-FL), and the staff of the Senate Foreign Relations Committee (Senators Menendez (D-NJ) and Corker (R-TN)).
